3. Use of net proceeds from Third-Party Allotment
- Net proceeds from the issuance of new investment units through the Third-Party Allotment (1,335,130,720 yen) will be kept as cash on hand and be deposited with financial institutions until the time of expenditure. The proceeds will be used to acquire Prologis Park Koga 3 and Prologis Park Tsukuba 1-A, which are to be acquired in October 2018 or after, and to fund future acquisitions of specified assets (as defined in Article 2, Paragraph 1 of the Act on Investment Trusts and Investment Corporations of Japan) or repay borrowings.
